FTLife debuts e-Connect Health Platform offering instant out-of-pocket cost estimation for newly launched outpatient colonoscopy and gastroscopy service

Hong Kong – FTLife Insurance Company Limited ("FTLife") today launched the **e-Connect Health Platform** ("**e-Connect**"), so customers can use a smartphone app to check whether their insurance will cover the cost of outpatient colonoscopy and gastroscopy procedures. The e-Connect solution also comes complete with exclusive value-added services during the promotion period.

Instant out-of-pocket estimates for easy financial planning

The Reach FTLife mobile app¹ enables customers to browse information from medical institutions and doctors on outpatient colonoscopy and gastroscopy procedures. The result is an instant out-of-pocket estimation based on cover granted by an existing policy owned by the policyholders. For example, the estimate will show as "\$0" if the medical expenses are fully covered by the policy. This enables policyholders to plan their finances with greater accuracy.

FTLife Chief Operations Officer Vivian Choi said: "FTLife understands the kind of health issues that concern customers, especially when it comes to fretting over whether or not a policy will cover the expense of outpatient colonoscopy and gastroscopy. Customers can now use e-Connect to discover if an existing medical insurance policy will cover the full out-of-pocket amount² before they make a decision. Furthermore, we will arrange Cashless Arrangement Service³ on behalf of customers, so they can go straight home to recuperate, without the bother of seeking pre-approval and making a claim for medical expenses."

No impact on no-claim discount

FTLife goes to great lengths to provide the kind of medical protection that meets a customer's treatment and rehabilitation requirements. Since gastrointestinal diseases are common in Hong Kong, we encourage customers to opt for outpatient colonoscopy and gastroscopy, for which the procedure is relatively simple, convenient and safe. More good news is the no-claim discount element of our medical insurance plans will not be affected by this kind of day surgery, and FTLife will pay out an outpatient surgery cash allowance⁴.

They can also book the first specialist consultation⁵ with a preferred specialist by our financial consultants. The Free VIP Room Upgrade Privilege is not guaranteed and subject to the actual supply of VIP room by the relevant medical institution at that time without prior notice.
