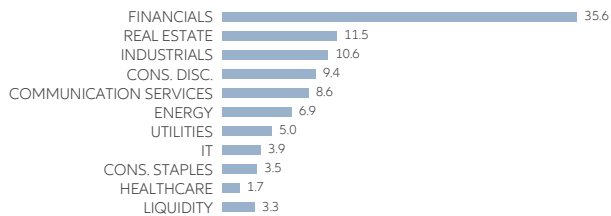
### Indexed Performance over 5 Years (NAV-NAV)
