

1. 投資於本基金可能涉及投資、股票證券、流動性、對手方及貨幣等風險。本基金主要投資於特定國家，與較多元化的投資組合相比，其涉及的集中風險或會更高。

本基金的投資目標是透過投資於投資經理認為將從經濟增長及中國發展中受惠的公司，在資產價值中達致長期資本增長。投資經理的政策是主要投資於已在中國及香港的認可交易所上市，並在中國及香港註冊成立的公司的股票，或在中國及香港擁有大部份資產或其他權益的公司的股票。投資經理亦可能投資於設於亞太區其他地方（日本除外），並有從中國發展中受惠的潛力（據投資經理的意見）的公司的股票。

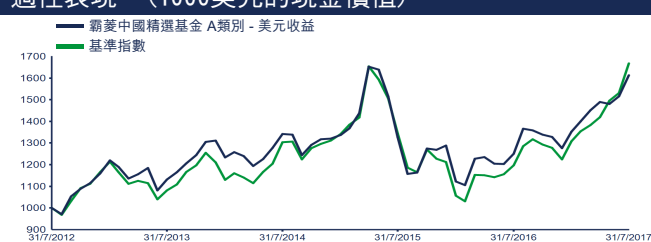

Investment Objectives¹

The objective of the Fund is to achieve long-term capital growth in the value of assets by investing in companies which the Investment Manager believes will benefit from the economic growth and development of China. The policy of the Investment Manager is to invest primarily in equities in companies quoted on Recognised Exchanges in China and Hong Kong and incorporated in China and Hong Kong, or which have a significant proportion of their assets or other interests in China and Hong Kong. The Investment Manager may also invest in equities in companies elsewhere in the Asia Pacific ex-Japan region with the potential, in the opinion of the Investment Manager, to benefit from the development of China.

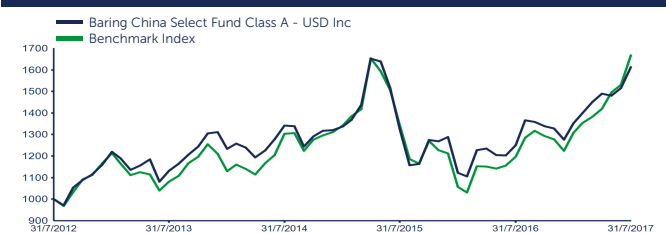
