These figures show as a NAV change of the Fund based on a hypothetical 10,000 investment in the share class.

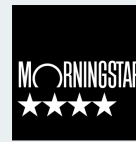

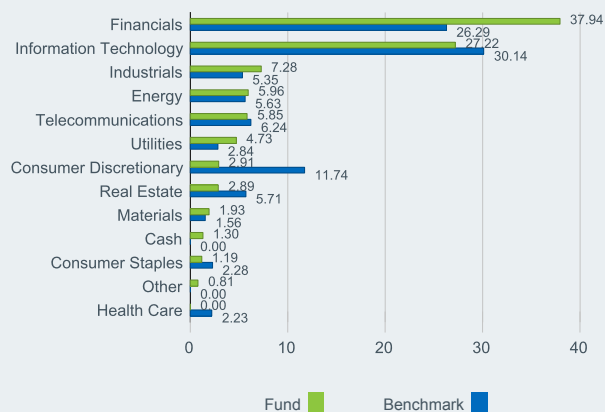

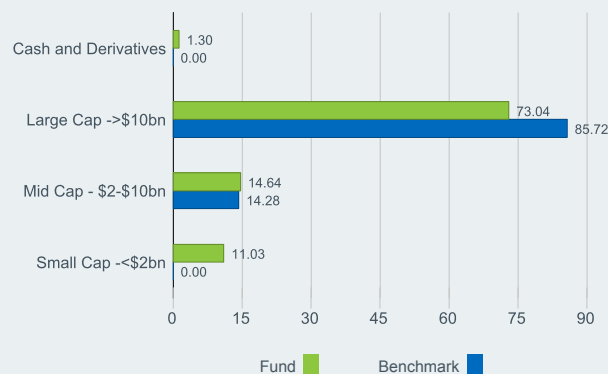
