Investment Emphases

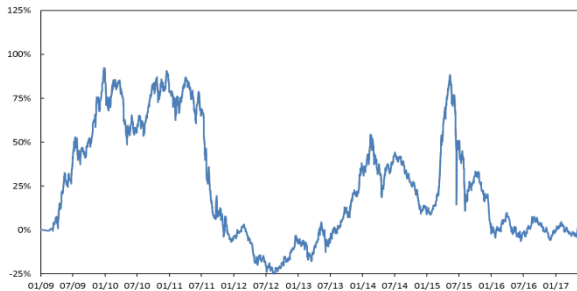
To achieve long-term appreciation of the unit price through capital growth and income appreciation by investing in a diversified portfolio of equities and equity related securities and bonds that are listed primarily on the Hong Kong stock exchange and/or any securities exchange and can benefit from the policies of the People’s Republic of China., Hong Kong, Macau and Taiwan.

Fund Review

China’s official manufacturing PMI, imports and exports, and industrial production were all better than market expectation. Retail sales growth was stable, while FAI growth moderated, suggesting liquidity tightening from the financial deleveraging to drag down the economic growth. In the overseas market, the Fed raised the benchmark rate by 25 bps as expected. It planned to begin the process of balance sheet normalization later this year and released the full plan for shrinking the balance sheet. In addition, the ECB kept its interest rates and the current monthly asset purchases pace of 60 billion euros unchanged. It also upgraded the Eurozone GDP forecasts for 2017-2019 to 1.9%, 1.8% and 1.7%.

In June, the Hong Kong market hovered around recent highs impacted by the tight liquidity in China, the Fed’s coming balance sheet reduction, and the British and French elections. MSCI announced that beginning in June 2018, it will include China A shares in the MSCI Emerging Markets Index and the MSCI ACWI Index. It was expected to attract massive global capital inflows into Chinese equity markets. We believe Hong Kong market should benefit as well with stronger connection between Hong Kong and China markets. Thanks to the supply-side reform and better-than-expected steel demand, the rebar prices maintained their upward trend this year followed by sheet products whose prices started to bottom out recently. As iron ore price has been stayed low, steel companies should see a substantial improvement in earnings for the first half of the year. Hence the Fund bought leading Chinese steel producers.

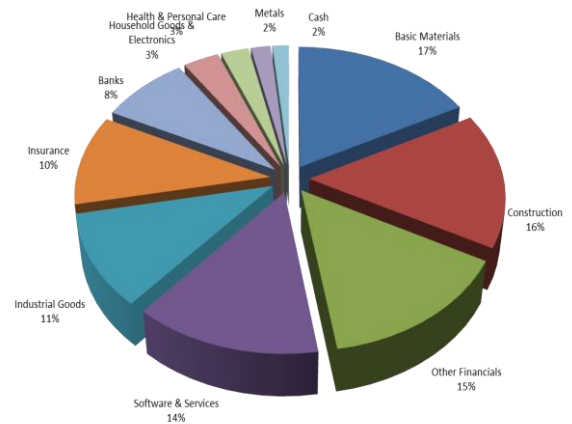
