- CCB International – China Policy Driven Fund (a sub-fund of CCB International Fund Series) (“Fund”) will invest in securities that may significantly be subject to the economic, political and social development and risks in the People’s Republic of China (“PRC”).

Investment Emphases

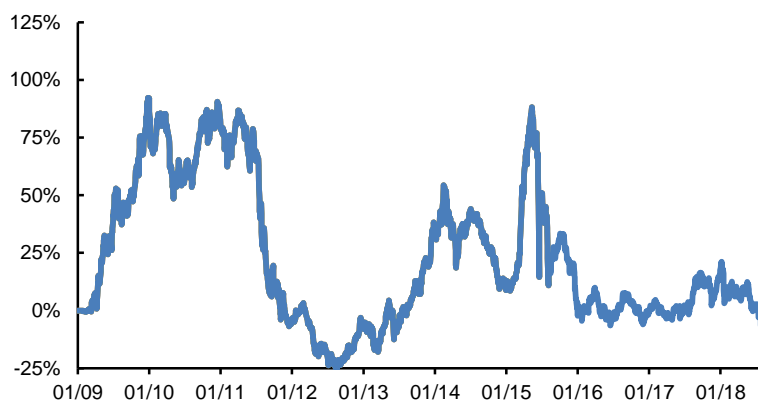
To achieve long-term appreciation of the unit price through capital growth and income appreciation by investing in a diversified portfolio of equities and equity related securities and bonds that are listed primarily on the Hong Kong stock exchange and/or any securities exchange and can benefit from the policies of the People’s Republic of China., Hong Kong, Macau and Taiwan.

Fund Review

In August, Hang Seng Index (HSI) declined by 2.43% and Hang Seng China Enterprises Index (HSCEI) was down by 1.35% respectively while trading volume was similar to previous month. During the month, focus was on the following points which could continue to affect the market going forward. (1) Sino-US trade war relapsed and could further exacerbate, especially with possible sanction in technology related sectors. (2) improvement in collection efficiency as a result of social security reform in mainland which could lead to negative impact on labor intensive sectors. (3) HSI Index and HSCEI Index constituent stocks reported 17.9% and 14.1% increase in 2018 interim net profit, which were higher than the growth rates in the past few years. However, pressure on second half’s profit growth should be noted.

We reallocated major exposures to defensive sectors such as local (Hong Kong) utility and insurance and would continue to select targets based on fundamentals, especially sectors and stocks with high certainty in growth, stable valuation and minimal negative impact from foreign exchange volatility and Sino-US trade war.

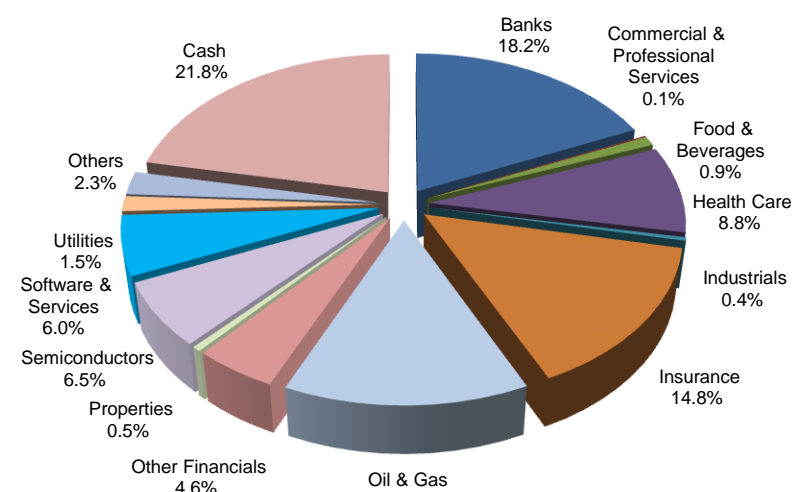
