

# CCB International – China Policy Driven Fund

## Investment Emphases



## Fund Review

Market dropped in December with HSI and HSCEI down by 2.3% and 4.3% respectively, thanks to major correction in the U.S. market and investors’ increasing pessimism on China’s macroeconomic downturn. In the foreseeable future, investment opportunities lie in discrepancies between economic fundamentals and volatility in investors’ expectations. Looking into 2019, we see investment value in financials and real estate which are sectors carrying China’s policy upside with attractive valuations, as well as potential investment opportunities from high-growth and ‘new economy’ stocks.

we maintain our defensive investment allocation strategy, staying alert on major systematic risks and focusing on companies with high defensiveness against market risk and high earnings certainty.


