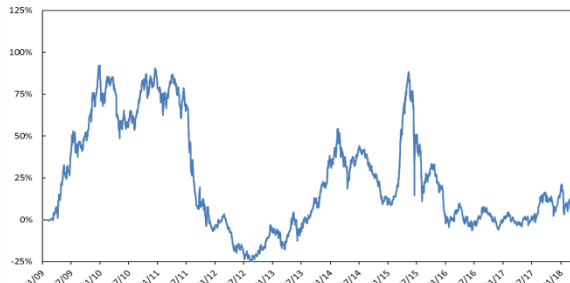
## Investment Emphases

To achieve long-term appreciation of the unit price through capital growth and income appreciation by investing in a diversified portfolio of equities and equity related securities and bonds that are listed primarily on the Hong Kong stock exchange and/or any securities exchange and can benefit from the policies of the People's Republic of China, Hong Kong, Macau and Taiwan.

## Fund Review

Look back in June, Hong Kong market's risk appetite declined at the back of escalation in China-US trade tension, depressing macro-economic data from China in May, increasing risk of economic deceleration resulting from further deleveraging in Mainland, and the huge depreciation in RMB against the USD Hong Kong market went into correction after a small spike at the beginning of the month. Hang Seng Index (HSI) had fallen by 5%, while Hang Seng China Enterprises Index (HSCEI) was down by 7.6% during the month. In June, the fund cut down its total exposures and minor adjusted the portfolio mix, via increasing the weightings in some defensive sectors. The fund would select further investment targets using the bottom-up approach. Although the market would continue to focus on China-US trade tension, and situation may even deteriorate further before recovering, from growth prospect and valuation perspective, the fund remains relatively optimistic on the medium to long term outlook of the Hong Kong market, particularly on the companies with strong competitive edge. Also, some high-quality companies had their valuation returned to more reasonable levels after the pullback thus creating buying opportunities for the fund.

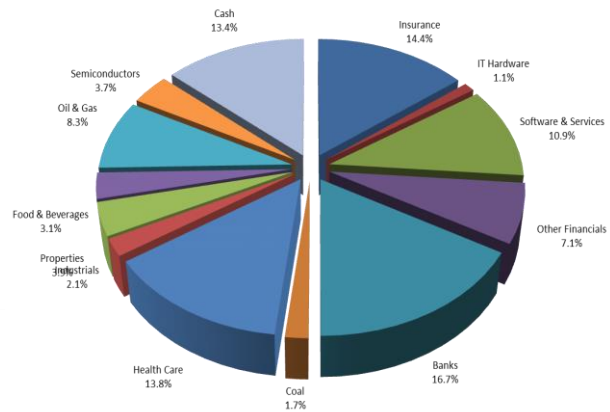
