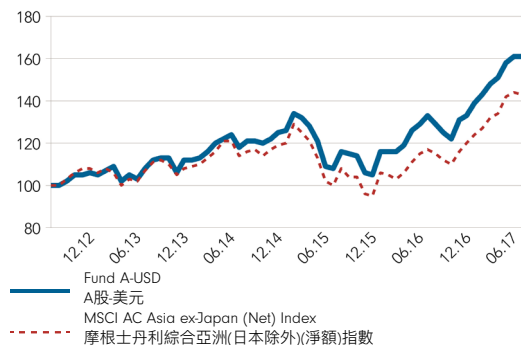
Equity 股票

- This fund invests primarily in special situations stocks and smaller growth companies in Asia, excluding Japan.
  - This fund may be subject to investment, the risks of investing in emerging markets specific to the Asian ex Japan market, foreign currency and RMB currency risk. The fund may invest in small and medium sized companies which may subject to more abrupt fluctuations in market price than larger companies. The fund may invest in China A shares directly through the Qualified Foreign Institutional Investor ("QFII") scheme and may incur losses due to limited investment opportunities, illiquidity of the China A shares market, and/or delay or disruption in execution of trades or in settlement of trades. The fund may invest in equity linked notes which may subject to the default risk of the structurer of the note. The fund may invest in certain eligible China A Shares via the Shanghai-HK Stock Connect which may be subject to quota limitations and regulatory risk.

### Investment Objective 投資目標

The fund invests principally in special situations stocks and smaller growth companies in Asia, excluding Japan. Special situations stocks generally have valuations which are attractive in relation to net assets or earnings potential with additional factors which may have a positive influence on the share price. Up to 25% of the portfolio can consist of investments other than special situations stocks and smaller growth companies. The fund may invest its net assets directly in China A and B Shares.

本基金首要投資於亞洲(日本除外)特別機會股份和小型增長公司。特別機會股份一般在資產淨值的估價較為吸引；或其盈利潛力加上其他因素，對股價有正面影響。特別機會股份及小型增長公司以外的投資項目，可佔投資組合最多不超過25%。基金可把其淨資產直接投資於中國A股及B股。

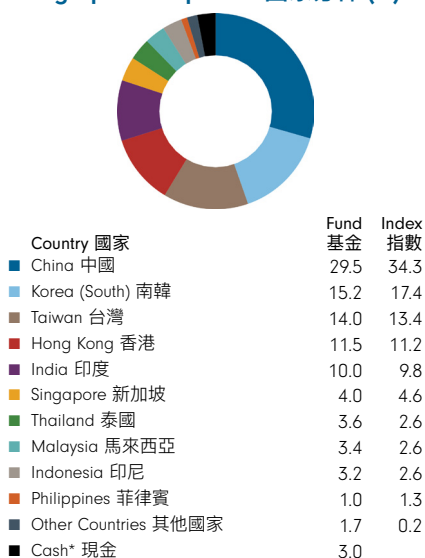

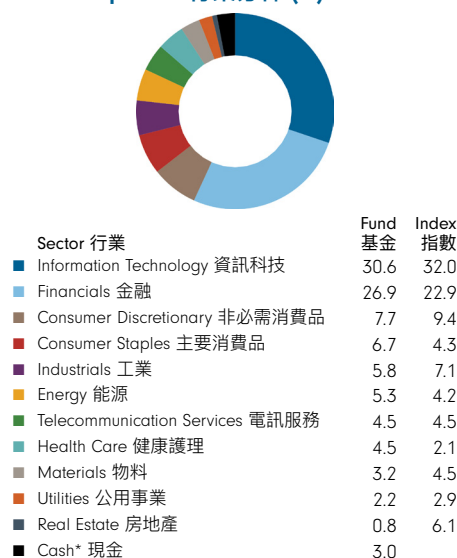
