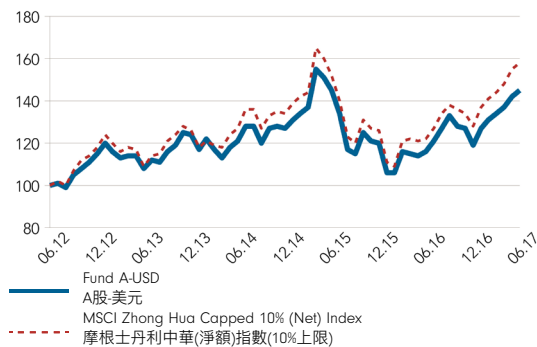

### Investment Objective 投資目標

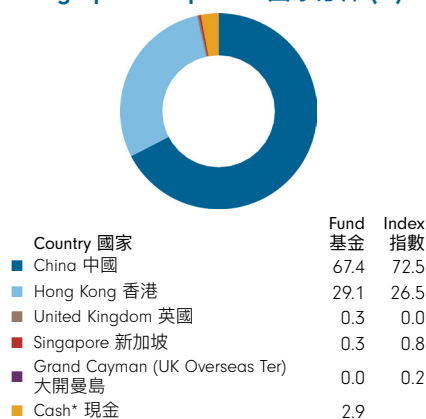

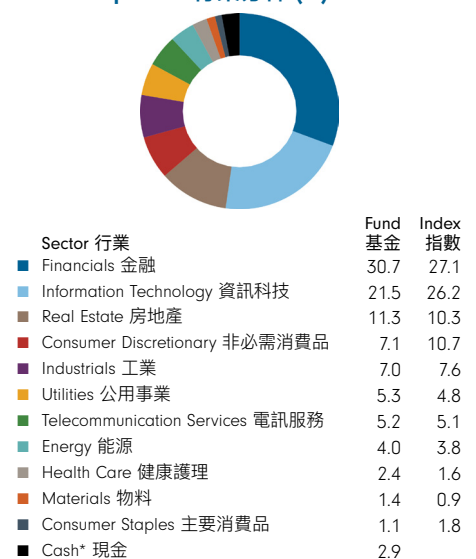
